**Course Description:** United States Government and Politics is a one trimester, required social studies class. Seniors must take both economics and government to fulfill the senior social studies requirement.

The course covers the legislative, executive and judicial branches of the U.S. government, the creation of public policy, state and local government, constitutional law concepts, the American legal system, and U.S. foreign policy.

**Text & required reading:** *Government Alive! Power, Politics and You* (2014 Teachers' Curriculum Institute). Students will also read news articles on a regular basis, and be asked to follow government current events. Other readings may be added during the term.

**Materials:** Bring your textbook, a folder & notebook *just for this class*, and a writing utensil to class every day. Notebooks will sometimes be collected.

**Expectations:** Be in class on time and ready to learn. Actively participate in classroom activities. Treat classmates, teachers and guests with RESPECT – LISTENING to each other is key. Because of the nature of studying government and politics, we will discuss some controversial issues and the focus will be on articulating views in a respectful and thoughtful way.

**Attendance:** It is important that you are in class. Many activities and discussions cannot be duplicated outside of class. If you miss a day of class, it is your responsibility to find out and make up what you missed. You are responsible for all information presented to the class.

**Community Service Requirement / Senior Project:** As part of the U.S. Government and Politics class, each student is required to complete at least five hours of community service. The community service requirement is 5% of a student's grade.

**Late Work:** Assignments are due at the beginning of the hour on the due date. The expectation is that you have work completed when you arrive at class. ALL assignments must be completed. Late work will be eligible for partial credit.

**Current Events:** We will regularly discuss government and legal current events in class. To effectively participate and understand these discussions, students need to watch/read/listen to state and national news on a regular basis. Additionally, students will be required to complete current events reports throughout the term. If you do not already do so, please get in the habit of staying on top of current events!

**Tests/Quizzes/Makeup Work:** Students will take chapter quizzes and unit tests. If a student has a planned absence on a due date, make arrangements to turn in work ahead of time. Make up tests may be different than the original tests.

**Plagiarism:** "Plagiarism is copying; it is cheating; it is stealing – yes, stealing the work of someone else and taking credit for it as if it were your own. It is serious, dishonest, and results in serious consequences!" (Student Handbook). Plagiarism and other forms of cheating will not be tolerated.
