QUESTIONS AND RESPONSES:

Question #1: Yamaha ships marching items separately. Can the RFQ be updated for the Bass Drums to be separated into individual line items? One line item to list the Drum, another line item to list the Carrier, another line to list the Case?

Answer: The items will not be separated into individual line items. The RFQ will specify that the Bass Drums be sold with a Case & Carrier so pricing should reflect a single gross price for all pieces. The ETA should reflect the arrival of all pieces.
