The student's first name

You must enter the student's first name.

Use the student's proper name, not a nickname. The student's first name must match the first name on his/her Social Security card.

The student's entry must contain only letters (A-Z), numbers (0-9), periods (.), apostrophes ('), dashes (-), or blanks (spaces). No other characters are allowed.

If you do not have a Social Security Number (SSN) and are not a citizen of the Federated States of Micronesia, the Republic of the Marshall Islands, or Palau, otherwise known as the "Freely Associated States," you cannot complete a FAFSA.

If you are a citizen of the Freely Associated States and you do not have an SSN, enter 666 in the first three positions of the SSN field. Leave the remaining six positions blank. Our system will assign you an SSN with the last six digits and display it in a message box when you reach the "Sign and Submit" page.

To retrieve a saved application, you must provide your first name, last name, SSN, date of birth, and the password entered when you began your initial FAFSA.

- If you save and exit your application prior to receiving the assigned 9 digit SSN, you will need to enter only 666 in the first three positions of the SSN field when logging back in to continue.
- If our system has already assigned you an SSN with the last six digits, you will need to enter the full assigned 9 digit SSN to open the saved application.

If our system has previously assigned you a nine-digit identifier beginning with 888, enter that identifier, but replace the 888 with 666.

Note: You should save the nine-digit SSN that is assigned to you and continue to use the same number every year you complete a FAFSA.





Special Circumstances

Important: You told us that you think you have a special circumstance and are unable to provide parental information. Before we allow you to proceed and skip the parental section of your FAFSA we must advise you of the following:

Under Federal law to the extent your family is able, they are primarily responsible for paying for your college expenses. To determine how much your family can afford to pay towards your college expenses, we must collect your financial information and your parents' financial information.

However, Federal law allows for some exceptions, if you have a special circumstance. The following are **examples** of some special circumstances where you may submit your FAFSA without providing parental information:

- Your parents are incarcerated; or
- You have left home due to an abusive family environment; or
- You do not know where your parents are and are unable to contact them (and you have not been adopted).

But not all situations are considered a special circumstance. The following are situations that would **not** be considered a special circumstance:

- Your parents do not want to provide their information on your FAFSA; or
- Your parents refuse to contribute to your college expenses; or
- Your parents do not claim you as a dependent on their income taxes; or
- You do not live with your parents.

COMMON MISTAKES

- **FREE Application for Federal Student Aid**
 - Some websites charge to help you fill out the FAFSA (information will, eventually, end up with Department of Education)
- **Marital Status**
 - As of the 1st day you file the FAFSA for the aid year
 - Contact school if wanting to update for any reason (marriage/divorce)
- **Household Size**
 - Must include student
 - Dependents: anyone student (or student's parent) will provide support of more than 50% during aid year
- **Adjusted Gross Income = Taxes Paid →**
- **IRS tax data transferred, then changed**
- **Saving vs. Submitting**
 - Must re-submit FAFSA after any change is made
