Mission Statement:

It is the purpose of the Anoka-Hennepin American Indian Parent Advisory Committee (PAC) and Indian Education Program to:

- Encourage and inspire academic achievement, graduation from high school, college readiness, emotional development and cultural awareness of our American Indian students.
- Serve as a resource to review and recommend accurate American Indian history, culture and language curriculum.
- To promote cultural awareness in the community and among staff, parents and students.

Parent Advisory Committee (PAC):

The PAC is composed of parents and guardians of American Indian students, school district representatives, and American Indian students (grade 7-12).

Duties:

- Work collaboratively with Indian Education Staff to support the mission of the Indian Education Program.
- Review and give input regarding MN American Indian Education Aid grant, Title VI grant, and related budgets.
- Provide guidance regarding program activities.
- Provide guidance regarding any other aspects of the program.

Time Commitment: The Indian Education PAC member shall commit to attend one (1) meeting per month (August – June) and special meetings called by the PAC Chairperson as necessary.

Eligibility Requirements for PAC:

- Must be a parent or guardian of an eligible American Indian student(s) grades K-12 or;
- Must be an eligible American Indian student (grades 7-12).
- No more than two members from the same immediate family.
- Any person that has been removed from the PAC or is an immediate family member of Indian Education program staff is not eligible.

Johnson O'Malley Committee (JOM):

The JOM committee is composed of parents and guardians of JOM-certified American Indian students**. This committee directly oversees the JOM grant/programming and approves all budget expenditures.

Duties:

- Work collaboratively with Indian Education Staff to support the mission of the Indian Education Program.
- Manage and approve JOM grant expenditures.
- Review and approve JOM grant & reports.
- Provide guidance regarding program activities.
- Provide guidance regarding any other aspects of the JOM program.

Time Commitment: The Indian Education JOM member shall commit to attend one (1) meeting per month (August – June) and special meetings called by the JOM Chairperson as necessary.

Eligibility Requirements for JOM:

- Must be a parent or guardian of an eligible JOM student** who attends Anoka-Hennepin or;
- A grandparent of an eligible JOM student who attends Anoka-Hennepin and who themselves possess at least one-fourth (1/4) Indian blood or is an enrolled member of a federally recognized tribe.
- Any person that is a family member of Indian Education program staff is not eligible.

**JOM certified students must be up to a 2 degree descent of an American Indian enrolled tribal member with a certified JOM form on file.
