GENERAL SAFETY GUIDELINES FAMILY AND CONSUMER SCIENCES CLOTHING CLASSES

Sewing Machines

- Keep sewing machine cords away from your feet or chair legs.
 Keep hands at a safe distance from the needle and presser foot when stitching.
 While threading the needle, have the power off and/or your foot off the foot control.
 Keep eyes on work when operating the machine
 Place hands on the plug, not the cord, when plugging the machine.
 Only one student- permitted at the machine at a time.

II. Pins and Needles

- Keep pins and needles out of mouth.
 Keep pins in pincushion or box.
- Keep pins at right angles to direction of stitching so pins can be removed before needles reach them.

III. Scissors/Shears

- Avoid gestures when using scissors and other sharp
 Pass the scissors with the handle toward the other person.
 Use a seam ripper for removing stitches. equipment.

IV. Iron

- Follow instructions when filling and emptying iron with water.
 Be sure hands are dry when handling iron.
 Before you begin to press, always test the temperature of the iron on a scrap of Bendle you begin a part of paper.
 paper.
 Do not test iron with your fingers or a drop of water.
 Stand a hot iron on heel rest, not flat on ironing board.
 Unplug the iron when not in use- pulling from the plug rather then the cord.

V. Other Hazards

- 1. Report to the teacher any dangerous conditions such as damaged cords, plugs, outiets, or burns.
- Shoes must be worn at all unles make.
 Practice appropriate behavior in classroom safety.
